have requested that I/We be provided by China Adoption With Love, Inc. (hereafter referred to as the Agency) with adoption service in China.

I/We have been informed that as many China adoption placement situations as there are, there are risks which may or may not be known to me/us, to the Agency, its staff, or others involved in assisting me/us in the matter. Such risks, as may be known, usually involve legal or medical issues and may be either significant or of little concern. I/We understand that notwithstanding the best efforts of the Agency and its staff and consultants, all risks will not be knowable or known. However, as significant risks become known to the Agency, I/We may be able to review their possible relationship to an adoption placement and to my/our continued participation in the process leading to the finalization of the adoption in China.

I/We have been informed by the Agency that there presently exist the following known risks: a) China Adoption With Love, Inc. places children who are often abandoned in the first several days of their lives and there are no family medical histories or prenatal medical records available, b) the Chinese government does do HIV testing and Hepatitis B tests on orphanage children, however they are sometimes not reliable, c) CAWLI cannot predict or guarantee the future health of any child. Therefore, as with any child, they adoptive parents must be prepared for any unforeseen medical condition which could arise in China and the states in future, d) China Adoption With Love, Inc. cannot predict or guarantee any child's future intelligence, personality, temperament or social behavior. e) China Adoption With Love, Inc. cannot guarantee a new assignment if I/We decline an assignment based on any reasons the Chinese government does not agree with.

I/We assume all risks, both known and unknown, what may at any time impair, delay, or preclude the readiness or availability of an assigned child for adoption. While the Agency agrees to make every reasonable effort to see that said child is both ready and available for adoption, the Agency is not able to guarantee that, given the nature, extent, and variability of whatever risks might be involved, the said child will be ready and available for adoption.

I/We, in consideration of the mutual covenants herein, agree that the Agency shall not be liable at law or in equity nor shall I/We bring, encourage to be brought, or instigate any legal action in events listed above.
